(pursuant to art. 13-14 of regulation (eu) 2016/679)

We inform you that during the event "Italian Tripartite Assembly on the European Open Science Cloud" (ITAEOSC2023), promoted by the Ministry of University and Research (Mur) in the context of the tripartite collaboration linked to the governance of the Strategic Co-Programmed Partnership Eosc, photos and audio/video recordings may be taken by authorized personnel, only for information and scientific dissemination purposes. The event will be held on 5 June 2023 in Rome at the National Research Council its recording will be made publicly accessible in streaming.

Therefore, in accordance with the provisions of art. 13 and art. 14 of EU Regulation 2016/679 (General Data Protection Regulation, hereinafter EU Regulation) we provide the following information:

PURPOSE OF THE TREATMENT AND LEGAL BASES

The acquired data will be processed only for the purposes connected to the performance of institutional activities, in particular for information and dissemination purposes of scientific, cultural and educational activities, pursuant to art. 6 of EU Reg. 2016/679, letter e) identified in the processing necessary for the execution of a task of public interest or connected to the exercise of public powers vested in the data controller.

PROCESSING METHODS

The collected images will be processed in a lawful, correct, pertinent way, in compliance with the principles indicated in the art. 5 of the GDPR and, in any case, in such a way as to guarantee its security and protect the maximum confidentiality of the interested party.

The installation and use of the images and video recordings are to be considered completely free of charge and in a totally correct manner. In no case will images and videos be used that jeopardize the honour, reputation and decorum of one's person, pursuant to art. 97 law n° 633/41 and art. 10 of the Civil Code. This authorization excludes any use for profit and transfer to third parties.

RECIPIENTS OF THE DATA PROCESSING

The photos and audio/video footage taken during the event may be published on the CNR websites, on the CNR social channels, in printed paper, and/or on any other means of dissemination, solely for information and scientific publication.

DATA RETENTION

The collected material will be kept in the CNR archives to have a historical memory of institutional events and activities and, if necessary, for any periodic historical publications.

DATA ACCESS RIGHTS

Pursuant to art. 15 of the EU Reg., the imaged subject has the right of access to the data being processed. Where applicable, the filmed subject also has the rights pursuant to articles 16-21 of EU Reg. 2016/67, as well as the right to complain to the Guarantor Authority.
